newly created role reports directly to the CFTC chairman, engaging with the Commission's new Market Intelligence Unit as well as market participants, industry analysts, economists, policy makers and other regulators. In this one-to-one interview with FIA's Walt Lukken, Busch will describe the work of the Market Intelligence Unit as it assesses, analyses and communicates current and emerging derivatives market dynamics, developments and trends, including the impact of new technologies and trading methodologies.

Busch was previously CEO of Bering Productions Inc, a company he founded, having joined from Bank of Montreal where he held a number of positions including Global Currency and Public Policy Strategist. He was an advisor to the White House, U.S. Treasury and Congress on the financial markets from 2005-2009.






