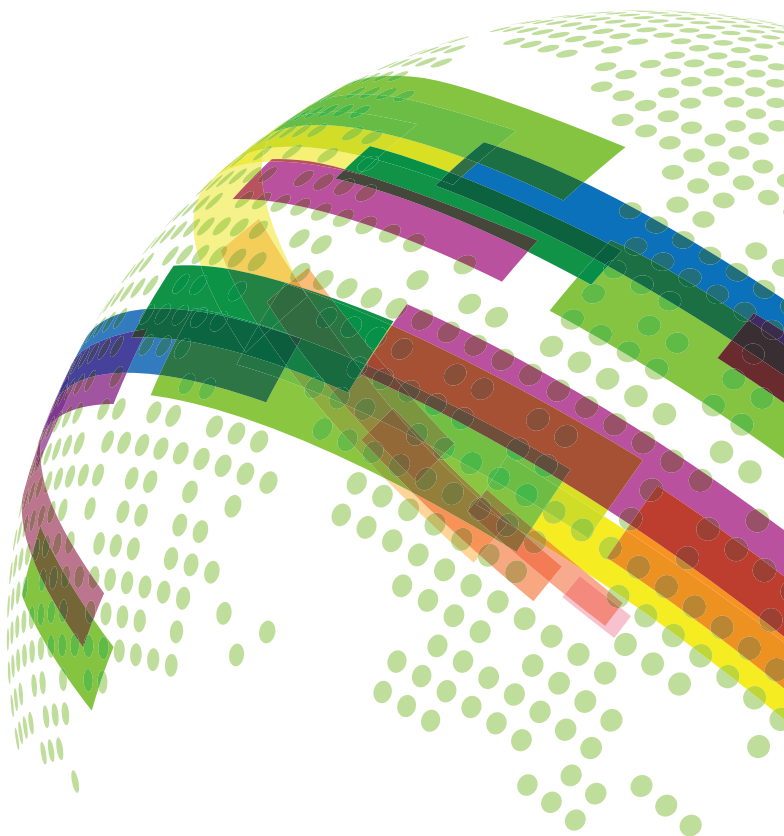

Over the last 10 years, the IDX Gala Dinner has raised nearly £1.6 million for Futures for Kids, including through the Kilt Challenge. This year FIA's very own Chief Commercial Officer Emma Davey has accepted the challenge and will be taking a new approach to raising £5,000 for FFK this year. I hope you'll help support this worthy effort.

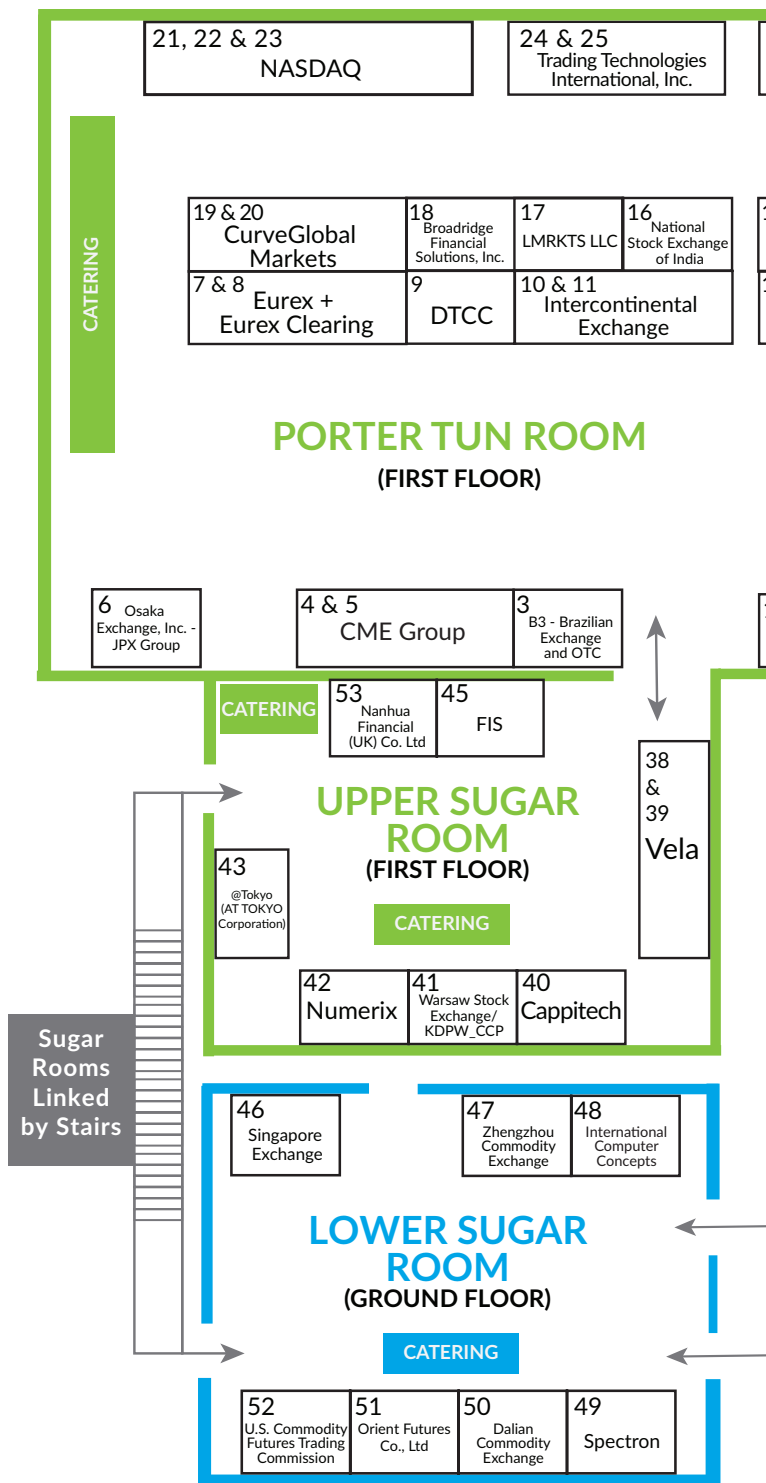

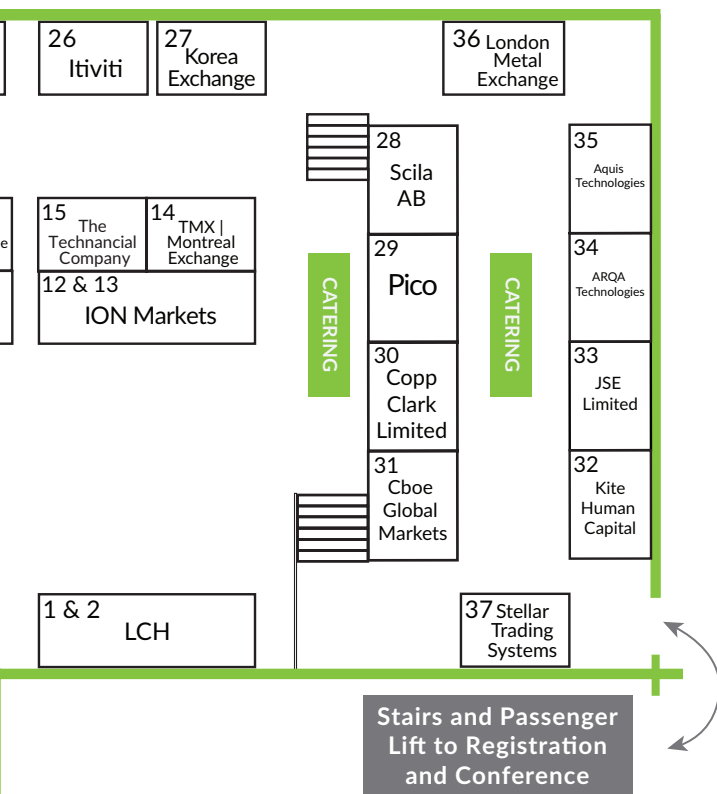

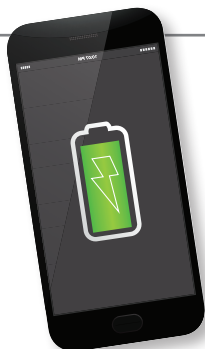
