## **PRINCIPAL TRADERS**

FIA PTG and FIA EPTA are separate affiliate organizations of FIA. These dues only apply to membership in FIA PTG or FIA EPTA. For firms that are active as principal traders only in Asia, please contact FIA for membership information.

## **FIA PTG**

- Level A \$40,000 >150 employees globally
- Level B \$30,000 ≥50, ≤150 employees globally
- Level C \$20,000 <50 employees globally

## **FIA EPTA**

- Level A \$75,000 >500 employees globally
- Level B \$60,000 >150, ≤500 employees globally
- Level C \$36,000 ≥50, ≤150 employees globally

#### **COMMODITY FIRMS**

Members of this category are market participants who use cleared derivatives to manage commodity price risk for themselves or on behalf of end users.

#### **CUSTODIAN BANKS**

Members of this category are banks providing custodial services and/or settlement banking systems for their customers.

#### **EXECUTING BROKERS & IDBs**

Members of this category are firms who execute transactions on behalf of customers but do not clear on behalf of customers.

#### **FUNDS & ADVISORS**

Members of this category include asset managers, hedge funds, pension funds, CPOs and other entities that manage money on behalf of investors.

## **HOUSE CLEARING BANKS**

Members of this category are banks providing clearing services for their House business only.

## **INDUSTRY SERVICE PROVIDERS**

Members of this category provide products and services to the cleared derivatives industry such as technology and other related activities.

#### **PROFESSIONAL SERVICES**

Members of this category provide professional services within the futures industry, such as consultancies, law firms, accountancy firms and public relations firms.

#### TRADING PLATFORMS & CCPS

Members of this category include regulated trading venues and CCPs providing trading and/or clearing functionality for listed derivatives products registered with, or regulated by a government agency. This category also includes Organized Trading Facilities (OTFs), Multilateral Trading Facilities (MTFs) and Swap Execution Facilities (SEFs).

#### PRINCIPAL TRADING FIRMS

Firms that use their own capital for trading in listed derivatives markets. Principal Trading Firms must apply to be a member of the FIA Principal Traders Group and/or the FIA European Principal Traders Association.
